- ★ If you graduate from a University and would like to start working in Japan, you need to apply for change of visa status.
- ★ If you would like to invite your spouse and child to Japan, you need to apply for certificate of eligibility for them.
- ★ If you would like to invite your parents to Japan, you need to make up their visa application documents for temporary visitor visas and send them to your parents.
- ★ If your child is born in Japan, you need to apply for acquisition of residence status for him/her.
- ★ If you would like to engage in part-time job in Japan, you need to apply for part-time job permit

The above are just typical examples of applications many foreigners would need.

Basically, you need to prepare and make up visa application documents required by the Immigration Bureau and bring them to the Immigration Bureau by yourself.

As you may know, if you fail in submitting appropriate documents required by the Immigration Bureau, it may take longer time than expected before visa is finally issued. (The documents required by the Immigration Bureau are not common to any applicants but could change depending on their status. It is possible that you have to submit those documents many times until they meet the requirements of the Immigration Bureau. )
